Minutes - Greer Co. Board of Commissioners held on 1/23/23 at 9:00 a.m. Advance notice posted on North entrance door of courthouse building & Greer Co. Commissioners office, 1/20/23.

Present: Mark Barnes, Chairman; Steven Fite, Vice Chairman; Brent York, Member; and Tiffany Buchanan, County Clerk.

Guests present: Jackie Jenkins, Sheriff; Steve McMahan, Undersheriff; & Cheryl Lively, OSU Extension Coordinator.

Mark Barnes called the meeting to order at 9:00 a.m.

There was no action taken on Meet with Elected Officials and Department Heads.

Steven Fite made a motion to approve the minutes from the January 9, 2023 Special Meeting. Brent York seconded the motion. York-aye; Barnes-aye; Fite-aye. All were in favor, motion carried.

Steven Fite made the motion to meet with Greer County Sheriff, Jackie Jenkins, for updates regarding the Jail, Staffing, and County-Wide Issues. Brent York seconded the motion. York-aye; Barnes-aye; Fite-aye. All were in favor, motion carried. Jackie Jenkins updated the Commissioners on County Wide Crime Issues. Steve McMahan, Undersheriff, presented the Commissioners with a statement on the Greer County Sheriffs Office for the year 2022 that included grants, reports, and jail updates.

Brent York made the motion to meet with OSU Extension Coordinator, Cheryl Lively regarding OSU and Fairground Updates. Steven Fite seconded the motion. York-aye; Barnes-aye; Fite-aye. All were in favor, motion carried. Cheryl Lively gave updates on repairs needed at the fairgrounds. She also briefed on the upcoming fair in February.

The documentation contained quotes on all repairs needed.

There was no action taken on Roads & Bridges.

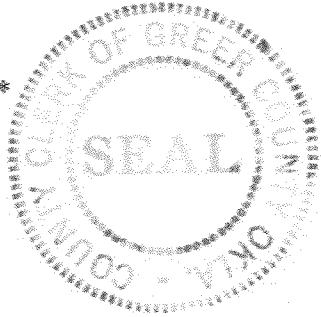
