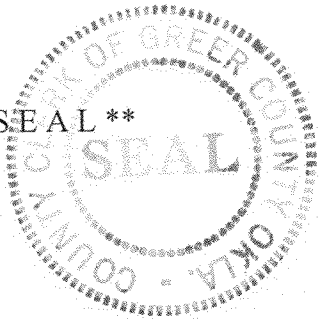
There was no new business to be discussed.
