Minutes - Greer Co. Board of Commissioners held on 3/25/2024 at 9:00 a.m. Advance notice posted on North entrance door of courthouse building & Greer Co. Commissioners office, 3/22/2024.

Present: Steven Fite, Chairman; Brent York, Vice-Chairman; Mark Barnes, Member; County Clerk, Tiffany Buchanan; & Jessica Wetsel, Commissioners Secretary.

Steven Fite called the meeting to order at 9:00 a.m.

There was no action taken on Round Table Meeting with Elected Officials and Department Heads.

Brent York made a motion to approve the minutes from the March 18, 2024 special meeting. Mark Barnes seconded the motion. Fite-aye; York-aye; Barnes-aye. All were in favor, motion carried.

Brent York made a motion to meet with OSU Extension Coordinator, Cheryl Lively regarding OSU and Fairground updates. Mark Barnes seconded the motion. Fite-aye; York-aye; Barnes-aye. All were in favor, motion carried. County Clerk, Tiffany Buchanan, delivered the message from the OSU Extension requesting how to move forward with potential repairs needed to their building. Sheriff, Steve McMahan, updated the Commissioners on the weekly meeting with the Police Chief regarding the discussion of moving the dispatch center.

Mark Barnes made a motion to approve the formation of and intent to participate in a public trust for the public use and benefit of certain counties located in Southwest Oklahoma that have or will receive settlement funds and/or grants to establish, own and operate a treatment facility (whether one or more) to abate and treat opioid addiction, to include the approval of authorization to apply for the grant funding from the Oklahoma Opioid Abatement Board and letter of intent of Memorandum of Understanding to participate in said public trust. Brent York seconded the motion. Fite-aye; York-aye; Barnes-aye. All were in favor, motion carried.

Brent York made a motion to approve Resolution #2024-09. *RE: Interagency coordination and collaboration to abate the opioid crisis and co-occurring substance use disorders and mental health conditions in Southwest Oklahoma.* Mark Barnes seconded the motion. Fite-aye; York-aye; Barnes-aye. All were in favor, motion carried.

Mark Barnes made a motion to approve Blanket Purchase Orders. Brent York seconded the motion. Fite-aye; York-aye; Barnes-aye. All were in favor, motion carried.

Brent York made a motion to approve Payroll. Mark Barnes seconded the motion. Fite-aye; York-aye; Barnes-aye. All were in favor, motion carried.

There was no action taken on New Business.


