Minutes - Greer Co. Board of Commissioners held on 5/22/23 at 9:00 a.m. Advance notice posted on North entrance door of courthouse building & Greer Co. Commissioners office, 5/19/23.

Present: Mark Barnes, Chairman; Steven Fite, Vice Chairman; Brent York, Member; and Tiffany Buchanan, County Clerk.

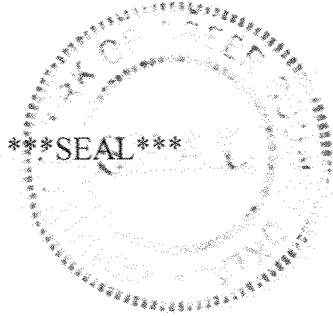
