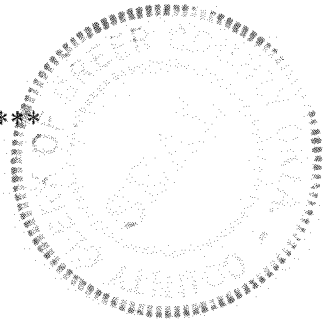
There was no action taken on New Business.
