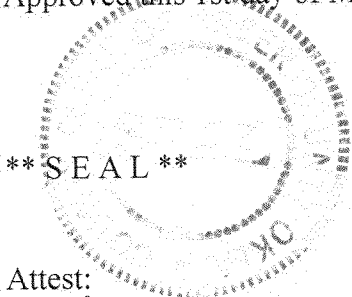


#5- There was no new business to discuss.


