Under new business, Vice-Chairman Nickell addressed rumors concerning an upcoming jackpot show that is being put on by the Mangum Ag Teacher. The rumor concerned whether or not the Granite Ag and 4H students would be allowed to show animals at the jackpot. Chairman York called the Ag Teacher. The Ag Teacher stated that there was not truth to the rumor. All FFA & 4H students are welcome. Vice-Chairman Nickell also addressed the question of the propane and how usage at the show would be monitored.
