Minutes - Greer Co. Board of Commissioners held on 1/24/22 at 9:00 a.m. Advance notice posted on North entrance door of courthouse building & Greer Co. Commissioner's office, 01/21/22.

Present: Brent York, Chairman; Mark Barnes, Vice-Chairman; Steven Fite, Member; and Jessica Wetsel, Commissioners' Secretary.

Guests present: Jackie Jenkins, Sheriff; Steve McMahan, Undersheriff; Cheryl Lively, OSU Extension Coordinator; Debi Davis, Election Board Secretary; & Glynadee Edwards, Safety Director.

Brent York called the meeting to order at 9:00 a.m.

Steven Fite made the motion to meet with Greer County Election Board Secretary, Debi Davis to approve the Kellpro Service Contract for the Election Board Office. Mark Barnes seconded the motion. York-aye; Barnes-aye; Fite-aye. All were in favor, motion carried. Debi Davis explained the back up and security system is State Mandated and Kellpro is being used by other counties for this specific service.

There was no action on meet with Elected Officials and Department Heads.

Steven Fite made the motion to meet with Greer County Sheriff, Jackie Jenkins, for updates regarding the Jail, Staffing, and County-Wide Issues. Mark Barnes seconded the motion. The Commissioners approved this request and stated the barn and all areas at the Fairgrounds must be cleaned and ready by March 5, 2022. Cheryl also stated that there will be some work needed around the OSU building; cleaning the drainage along the building and removing some trees.

Steven Fite made the motion to approve the ODOT Project Maintenance, Financing and Right-of-Way Agreement. *Re: Cottonwood Road, State Job# 33926(04)(05)(06)(07)*. Mark Barnes seconded the motion. York-aye; Barnes-aye Fite-aye. All were in favor, motion carried.

Mark Barnes made the motion to approve Resolution #2022-06. *Re: Project Agreement for the Overlay of County Road, Cottonwood Road, State Job #33926(04)*. Steven Fite seconded the motion. York-aye; Barnes-aye Fite-aye. All were in favor, motion carried.

Mark Barnes made the motion to approve Resolution #2022-07. *Re: Continuing a Burn Ban for Greer County*. Steven Fite seconded the motion. York-aye; Barnes-aye Fite-aye. All were in favor, motion carried. Burn Ban continued for two (2) more weeks.

Mark Barnes made the motion to discuss New Business. Steven Fite seconded the motion. York-aye; Barnes-aye; Fite-aye. All were in favor, motion carried. Glynadee Edwards requested hand rails be put on the steps on the Courthouse for a safer entrance. This item will be on the next agenda to approve the request.
