

Minutes - Greer Co. Board of Commissioners held on 10/13/20 at 9:00 a.m. Advance notice posted on north entrance door of courthouse building & Greer Co. Commissioner's office, 10/08/20.

Present: Chairman Terry Nickell, Vice-Chairman Steven Fite (arrived at 9:04), Brent York, County Clerk Leanne Coffman and Commissioners' Secretary, Jessica Wetsel.

Terry Nickell, Chairman called the meeting to order at 9:00 a.m.

The Sheriff's Dept. had a busy weekend responding to an accident, accidental shooting, fire, problems at the jail and various other problems.
