

Minutes - Greer Co. Board of Commissioners held on 11/09/20 at 9:00 a.m. Advance notice posted on north entrance door of courthouse building & Greer Co. Commissioner's office, 11/05/20.

Present: Chairman Terry Nickell, Vice-Chairman Steven Fite, Brent York, County Clerk Leanne Coffman and Commissioners' Secretary, Jessica Wetsel.

Guests present: Jackie Jenkins, Sheriff; Chris Hodges, Dobson Technologies; and Zach Maxwell, Editor-Mangum Star.

Terry Nickell, Chairman called the meeting to order at 9:00 a.m.

Steven Fite made the motion to meet Chris Hodges, Dobson Technologies. Brent York seconded the motion. York-Aye; Nickell-Aye; Fite-Aye. No nay votes. All were in favor, motion carried. Mr. Hodges explained that Dobson Technologies should be able to compete with current expenditures for phone & internet services, as well as supply the Courthouse with better service. Mr. Hodges also explained how Dobson Technologies supplies services versus how we currently receive services. They will also need to look at the infrastructure of the building to see if any changes need to be made to accommodate the new system.

Steven Fite made a motion to approve a Transfer of Funds to correct an error and make an adjustment to revenue. Brent York seconded the motion. Nickell-aye; York-aye; Fite-aye. All were in favor, motion carried.

Brent York made the motion to discuss a Resolution pertaining to allocating Grant Funds. Steven Fite seconded the motion. Nickell-Aye; York-Aye; Fite-aye. No nay votes. All were in favor, motion carried. After discussion the BOCC recommended the following allocations. Highway 1102 fund-\$36,391.67; Emergency Fund #1311-\$33,000.00; and the remaining funds to fund #1565 "Covid Aid and Relief Fund" to be used for the Greer County Sheriff's Dept.

Steven Fite made a motion to approve the COVID-19 Policy and Procedures with the following amendments: Page 1-Remove "and have a negative test result before returning to work"; Page 2-Remove "Enforce social distancing and compliance with all required precautionary measures"; Page 3-Remove the section referred to as "Access Issues". Brent York seconded the motion. Nickell-aye; York-aye; Fite-aye. All were in favor, motion carried.

Brent York made the motion to recess. Steven Fite seconded the motion. York-Aye; Nickell-Aye; Fite-Aye. No nay votes. All were in favor, motion carried. Meeting recessed at 10:11 a.m.
