Minutes - Greer Co. Board of Commissioners held on 11/22/21 at 9:00 a.m. Advance notice posted on North entrance door of courthouse building & Greer Co. Commissioner's office, 11/18/21.

Present: Steven Fite, Chairman; Brent York, Vice-Chairman; Mark Barnes, Member; Tiffany Buchanan, County Clerk; and Jessica Wetsel, Commissioners' Secretary.

Guests present: Jackie Jenkins, Sheriff; Cheryl Lively, OSU Extension Coordinator; Landon Brooks, Korey Thomas, & Jenny Hernandez, Greer County Ambulance Board; Dustin Lively & Mickey Lively, citizens; and Chris Wilson, Mangum Star Editor.

Steven Fite called the meeting to order at 9:00 a.m.

Brent York made a motion to meet with Greer County Ambulance Board. *RE: Requesting Monetary Assistance*. Mark Barnes seconded the motion. Fite-aye; York-aye; Barnes-aye. The Commissioner's also explained waiting for the final ruling of the ARPA Funds before making any major purchases or expenditures that the County could potentially have to repay. All agreed that the EMS is a needed service that is vital to our community.
