Minutes-Greer Co. Board of Commissioners held 2/26/18 at 9:00 a.m. Advance notice was filed in the office of the County Clerk at 8:21 a.m. on 2/23/18 and notice was posted on north entrance door of courthouse building & Greer Co. Commissioner's office.

Present: Steven Fite, Chairman, Brent York, Terry Nickell & County Clerk Leanne Coffman and guest, Cara Gluck, Health Dept. Administrator and Jerry Dean, Salesman 7 Oil.

Chairman Fite called the meeting to order at 9:00 a.m.
