Brent York made the motion to approve Resolution 2012-11 RE: Question 10. Jerald Gifford seconded the motion. The vote: Gifford-Aye; York-Aye; Fite-Aye. No Nay Votes. Motion carried. WHEREAS, The Board of County Commissioners has committed to an effort to provide safe, maintained roads and bridges for the largest non reservation Native American population in the United States; and WHEREAS, all of the original road maintenance easements were granted by the various tribes within the state; WHEREAS, and all roads and bridges are utilized by the Native American Members of our Great Tribes; and WHEREAS, the BIA and FHWA have suggested a change to rule 10 as published in Vol. 69, No 137 of Monday, July 19, 2004 of the Federal Register, addressing the utilization of IRR funding restrictions to Tribal and BIA owned lands, would diminish a Great Native American State's participation in IRR fund. NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners

of Greer County opposes the proposed changes to this rule, with the continued goal of provision of fairness for all Native Americans regardless of their State of residency.
