Dwayne Mills, Undersheriff discussed repairs to the County Jail and other needs of Sheriff's Department, mentioning a program available thru ACCO for a "trash deputy", which allows the County to set up an officer to patrol and issue citations for littering and illegal dumping. No further action was taken at this time.

Cheryl Lively discussed 4-H community project and clean up of fairgrounds along with other upcoming events within the OSU Extension.

The commissioners met with Casey Paxton to discuss financial condition of the general fund, with a public notice to be prepared and published soon to advise public of critical steps that need addressed in order to better assist our community in the daily routine of managing and running our county entities.
