

Minutes - Greer Co. Board of Commissioners held on 5/13/19 at 9:00 a.m. Advance notice posted on north entrance door of courthouse building & Greer Co. Commissioner's office, 5/9/19.

Present: Chairman Brent York, Vice-Chairman Terry Nickell, Steven Fite, County Clerk Leanne Coffman and Commissioners' Secretary, Jessica Wetsel.

Brent York, Chairman called the meeting to order at 9:00 a.m.

Steven Fite made the motion to meet with ADA Kelli Woodson to discuss changes to the Comanche County Regional Juvenile Detention Center Contract. Terry Nickell seconded the motion. After some discussion it was decided that no revisions were necessary and the Handbook was approved for distribution with an effective date of June 1, 2019.
