Minutes - Greer Co. Board of Commissioners held on 05/04/20 at 9:00 a.m. Advance notice was posted on north entrance door of courthouse building & the Greer County Fair barn.

Present: Terry Nickell, Chairman; Steven Fite, Vice-Chairman; Brent York, Member; County Clerk, Leanne Coffman; and Jessica Wetsel, Commissioners' Secretary.
