Brent York made the motion to approve the Greer County 2020-2021 Estimate of Needs; Fiscal Year 2019-2020 Estimate of Needs and the Publication Sheet. Steven Fite seconded the motion. York-Aye; Fite-Aye; Nickell-Aye. No Nay Votes. All were in favor and motion carried. The County Clerk, Leanne Coffman, gave a brief run down on the budget and how much there was to be allocated.

Brent York made the motion to approve Resolution #2020-18 regarding the Cares Act Grant money that the State Election Board has available to reimburse the County Election Boards for expenses incurred directly as a result of COVID-19 during the 2020 Statewide Elections. Steven Fite seconded the motion. York-Aye; Fite-Aye; Nickell-Aye. No Nay Votes. All were in favor and motion carried.

Brent York made the motion to approve the letter for the Greer County Hazard Mitigation Plan Application Preparation. Steven Fite seconded the motion. York-Aye; Fite-Aye; Nickell-Aye. No Nay Votes. All were in favor and motion carried.

Steven Fite made the motion to New Business. Brent York seconded the motion. York-Aye; Fite-Aye; Nickell-Aye. No Nay Votes. All were in favor and motion carried. Mr. Fite discussed the volunteer Fire Departments surplus fire equipment. Some equipment will be returned and other equipment will be added.

There was no action taken regarding Roads & Bridges.
