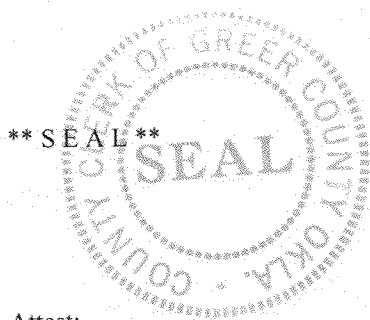
There was no action taken to Meet with the Industrial Trust Authority.

There was no action taken on Roads & Bridges.




