There was no action taken on Round Table Meeting with Elected Officials and Department Heads.

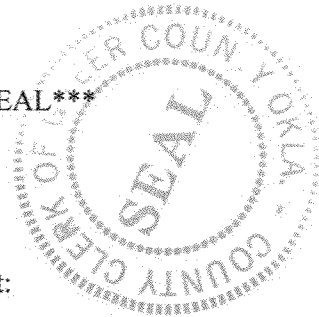
