Brent York called the meeting to order at 9:00 a.m.

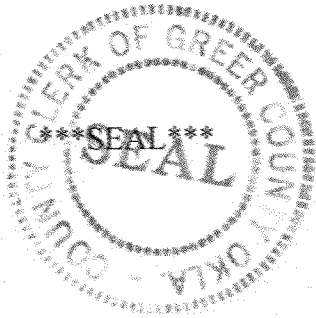


