Minutes - Greer Co. Board of Commissioners held on 4/17/23 at 9:00 a.m. Advance notice posted on north entrance door of courthouse building & Greer Co. Commissioner's office, 4/13/23.

Present: Mark Barnes, Chairman; Steven Fite, Vice-Chairman; Brent York, Member; & County Clerk, Tiffany Buchanan.

Mark Barnes called the meeting to order at 9:00 a.m.


