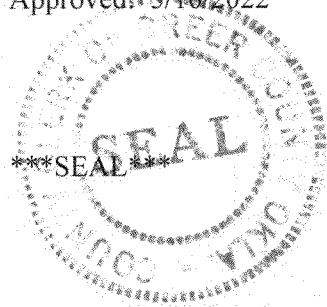


There was no action taken on Roads & Bridges.
