Minutes - Greer Co. Board of Commissioners held on 6/2/25 at 9:00 a.m. Advance notice posted on north entrance door of courthouse building & Greer Co. Commissioner's office, 5/30/25.

Present: Brent York, Chairman; Mark Barnes, Vice-Chairman; Steven Fite, Member; County Clerk, Tiffany Buchanan & Shelby Monroe, Commissioners' Secretary.

Brent York called the meeting to order at 9:00 a.m.

These residences provide employment, education, and transportation support, helping individuals transition from treatment to the

community while reducing relapse risk. Mark Barnes seconded the motion. York-aye; Barnes-aye; Fite-aye. All were in favor, motion carried.

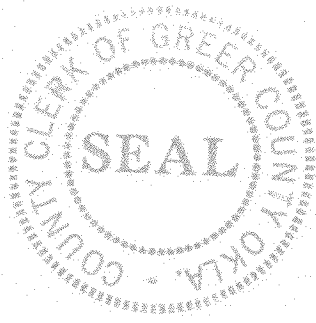
There was no action taken on Roads & Bridges.
