Minutes - Greer Co. Board of Commissioners held on 6/27/22 at 9:00 a.m. Advance notice posted on North entrance door of courthouse building & Greer Co. Commissioner's office, 6/24/22.

Present: Brent York, Chairman; Mark Barnes, Vice-Chairman; Steven Fite, Member; Tiffany Buchanan, County Clerk; and Jessica Wetsel, Commissioners' Secretary.

Guests present: David Thomas, District Attorney; Jackie Jenkins, Sheriff; William (Bill) Pipho; and Gary Ray Winters.

Brent York called the meeting to order at 9:00 a.m.

Steven Fite made a motion to meet with William (Bill) Pipho for discussion on the maintenance of East County Road 1512. Mark Barnes seconded the motion. York-aye; Barnes-aye; Fite-aye. There was no action taken on Roads & Bridges.




