There was no action taken to Request the Excise Board to Appropriate Funds.

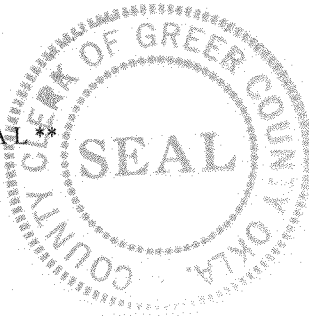
There was no action taken on Roads & Bridges.


