Minutes - Greer Co. Board of Commissioners held on 08/25/25 at 9:00 a.m. Advance notice posted on north entrance door of courthouse building & Greer Co. Commissioner's office, 08/22/25.

Present: Brent York, Chairman; Mark Barnes, Vice-Chairman; Steven Fite, Member; County Clerk, Tiffany Buchanan & Shelby Monroe, Commissioners' Secretary.

Brent York called the meeting to order at 9:00 a.m.

Steven Fite made a motion to meet with the Elected Officials and Department Heads. Mark Barnes seconded the motion. York-aye; Barnes-aye; Fite-aye. All were in favor, motion carried. Tiffany Buchanan, County Clerk, presented the Commissioners with lists of items the Elected Officials would like incorporated into the upkeep of the Courthouse.




